## Japan World Exposition 1970 Commemorative Fund Project

The Japan World Exposition held in 1970 showed unprecedented great success by the participation of 77 countries and the attendance of more than 64 million people.

In the theme, "Progress of Mankind and Harmony", of the Expo, the human wish of harmonious progress in the future which reflects the history of having brought bad influences to natural environment by the development of science and technology, and the discord of the different societies, was included.

The Japan World Exposition 1970 Commemorative Fund (JEC FUND) have not received any subsidy from nation. We have managed the part of the proceeds of exhibition as a fund, and with the resulted yield, have granted subsidies to various activities such as national or international cultural exchange, science, education etc.

Beginning April 1st 2014, the management of the FUND has been transferred to KANSAI·OSAKA21st Century Association.

The FUND wishing for human race will accomplish harmonious progress and more rich life environment will be established, will continue contributions to the society by helping, national and international activities such as cultural exchange, science, education, art, transmission of Japanese traditional culture etc.

## Activities contributing to promotion of international mutual understanding

### ● Projects contributing to international cultural exchange and international goodwill

Construction of Japanese garden, holding of Japan festival, invitation of Japanese traditional performance art, exchange of talented person with Japanese people.



### ● International projects in the fields of academic study, education, social welfare, medical care, and hygiene and public health

Buying of audiovisual equipment for Japanese language education, translation of Japanese publications, holding of international conference referred to Japan.



### ● International projects designed for conservation of nature and the human environment

Nature protection activity like afforestation, invitation or dispatching of technical expert for environmental protection, preparation of natural history museum etc. holding of international conference concerning environment.



## An outline of JEC FUND

### Upper limits of the JEC Fund Grant


The amount of the JEC Fund Grant is between ¥1,000,000 and ¥10,000,000, and should account for less than half of the total project expenses applicable to the JEC Fund Grant. Upper limit of the JEC Fund Grant is specified for each type of project as follows.

(1) Performance or exhibition:	¥4,000,000
(2) International conference:	¥3,000,000
(3) Purchase of books:	¥2,000,000
(4) Publication of books or film/TV program production, etc.	¥3,000,000
(5) Invitation or dispatch of experts:	¥3,000,000
(6) Purchase of equipment for learning Japanese:	¥5,000,000
(7) Purchase of equipment other than equipment for learning Japanese:	¥8,000,000
(8) Construction or enhancement of a facility:	¥10,000,000
(9) Project conducted for an objective for which the JEC Fund Grant makes an especially large contribution, e.g. exhibiting at an international exhibition, etc.	¥10,000,000


- Every year on July 1st, we open at our home page the guidelines for applications related to the project which will be undertaken between April in next year and March in the year after next.
- The applications will be accepted beginning August 1st until September 30th.
- Through the examination of FUND screening committee, the result of adopted or not adopted will be notified in March.
